From Secretary's Desk

How Fast India will grow in the coming years and how vast and varied the employment opportunities will be for the growth, depends on how will we encourage the innovative and entrepreneurial urge amongst our people. TBIs like MIIC have a crucial role to play in assisting budding innovators by incubating their Startups and hand-holding them for growth. Startups in high- technology domains are important for the nation, so its time to prise open markets for new tech based products and services, as the country has a rapidly growing appetite for them. MIIC has a vital role to play in this regard.

For MIIC the year 2018-19 witnessed a mix of happy as well as an unhappy events. The new building of MIIC was inaugurated by the Honorable Union Minister of HRD, Sh. Prakash Javadekar on 24/09/2018. This state of art MIIC building has 50,000 sq. feet of working area, Mentoring Rooms, Machine Hub and lounge, 2 large seminar halls along with 4 meeting rooms and a board room. Co-working spaces, 60 dedicated office spaces, advanced softwares and machines to support the registered startup. Ironically around the same time we lost our then secretary Dr. Awadhesh Bhardwaj to the cruel hands of destiny. Humbly bowing down to the might of the nature, we silently vowed to commit ourselves to MIIC's mission with dedication, sincerity and focus.

The year saw many innovators applying for incubation and after through screening based on innovativeness and scalability criteriaon, 20 startups were finally recommended by the recommendation committee for incubation. The total no.of startup presently working in MIIC are 33.

MIIC is devoted to the comprehensive development, promotion and growth of incubated startups. To achieve this, MIIC organized myriad programs and activities for the benefit of its Incubatees, student innovators and Startup ecosystem stakeholders at large. The programs ranged from Expert talks, Workshops, Seminars, Conclave and monthly Startup Saturday programs to Competitions, Hackathons, FDPs / MDPs, Investor meets and Summer Internship Program. Besides this MOUs for Partnerships were signed with Software Technology Parks of India, (STPI), Department of Information Technology & Communication, Government of Rajasthan and Sanativefix Technologies Private Limited. This further added value for the Startups incubated at MIIC.

The facility of Machine hub was further enriched by the purchase of latest machinery and softwares like Laser Cutting Machine, Laser Weilding Machine, Signal Analyzer, BIOPAC, LMM, Catia, SPSS, Electrochemical Machine, Xylink, 3D Printers, Photometric Machine Vertical CNC Milling Machine etc. The DST funds were thus aptly utilized for the benefits of incubatees.

Its time for MIIC when the incubatees must be pushed for a quick validation of their models with end customers and an early revenue generation. The annual report of 2018-2019 signifies our commitment towards handholding and supporting startups for achieving their dreams of success.

About the Society

MIIC is a Technology Business Incubator (TBI) sponsored by DST GOI, New Delhi, and was established in December 2016, MIIC has been registered as a society under the Rajasthan Societies Act, 1958. MIIC's objective is to provide platform for Conceiving, Realizing, Promoting & Nurturing knowledge based Innovation & Entrepreneurship amongst all aspiring entrepreneurs. MIIC extends incubation support to startups primarily but not limited to the areas of Product or Process design / Re-design, Material or Process innovation, Information & Communications Technology..
